- Payments are due at time of signing a “Contract for Reservation of Inurnment or Remembrance Wall Space.”
- Payments may be made in installments. If so, the initial payment shall be for 25% of the full price, due at time of signing.
- If the purchaser cannot complete payment within six months of application for a niche or stone, 80% of the payments made will be refunded to the purchaser.
